

#### **EASTER DUTY**

From the Code of Canon Law:

Can. 920 §1. After being initiated into the Most Holy Eucharist, each of the faithful is obliged to receive holy communion at least once a year.

§2. This precept must be fulfilled during the Easter season unless it is fulfilled for a just cause at another time during the year.

Can. 989 After having reached the age of discretion, each member of the faithful is obliged to confess faithfully his or her grave sins at least once a year.

In the United States, the "Easter season" is taken to mean any time from the first Sunday of Lent all the way to Trinity Sunday.

If any children wish to make their first Communion during the Easter season, their parents are asked to contact the pastor.

## ANNOUNCEMENT FROM THE DIOCESE OF FORT WAYNE-SOUTH BEND

It remains important for our Church to protect children and young persons from the evils of abuse. To abuse a child is a sin. The Diocese of Fort Wayne-South Bend

remains committed to upholding and following its guidelines, policies and procedures that were implemented for the Protection of Children and Young People. These can be reviewed on the Diocese's website, <a href="www.diocesefwsb.org">www.diocesefwsb.org</a> under "Youth Protection."

If you have reason to believe that a child may be a victim of child abuse or neglect, Indiana law requires that you report this to civil authorities. If you or someone you know was abused as a child or young person by an adult, you are encouraged to notify appropriate civil authorities of that abuse. In addition, if the alleged abuser is or was a priest or deacon of the Catholic Church, you are encouraged to contact Mary Glowaski, Victim Assistance (260)399-1458, Coordinator, mglowaski@diocesefwsb.org, or Rev. The Diocese is committed to helping prevent the abuse or neglect of children and young people and to assist those who claim to have suffered harm as a result of such abuse.

#### **Abortion Industry Exposed!**

For years we have been told that legal abortions were necessary for the health and well-being of the mother. It is a lie. Dr. Bernard Nathanson, cofounder of the National Abortion Rights Action League, who later became a Christian pro-life activist, admitted that his group blatantly lied about the number of women dying from illegal abortions.

The truth is only a small percentage (less than one-tenth of 1 percent by some counts) of the 1.3 million abortions in the United States each year are to save the mother's life. Instead statistics suggest that 85 percent of all abortions are performed as a means of birth control and are three times more likely to be by a woman on Medicaid. Family planning and abortion clinics in the United States are a \$2 billion a year industry with a 1.3 percent growth over five years, with 40 percent of all the country's abortions being performed at Planned Parenthood.

Abortion clinics, by and large, are seedy, dirty, nefarious profit centers that don't care a lick about the woman or her rights. They are all about turning

a quick buck. Just look at the recent cases of Dr. Kermit Gosnell in Philadelphia or Dr. Douglas Karpen in Houston whose depraved actions are just too disgusting to describe in this family bulletin. Another clinic threw remains on its roof to avoid hazardous waste removal fees. The list of abusive practices goes on and on.

Fortunately, slowly but surely, the dirty secrets are being exposed to the public. It's about time!
