The season of Lent begins this Wednesday. There will be two Masses Weds. Feb. 17, one at 7:00 AM and another (high) at 7:00 PM. Ashes will be distributed before both Masses.

FRIDAYS OF LENT
We are offering a simple meatless supper on the Fridays of Lent (February 19 and 26; March 5, 12 and 26th) following Stations of the Cross at 6:00 pm and Mass at 6:30 pm. **THERE WILL BE NO STATIONS OF THE CROSS OR MEATLESS SUPPER ON FRIDAY, MARCH 19, AS THAT IS THE FEAST OF ST.**

On the 5 Fridays we have a meatless supper, the Church will provide drinks and some of the food but we need people to pitch in and sign up to bring other dishes. There are detailed **SIGN UP SHEETS for all five Fridays of Lent** on a blue clipboard on the table by the west entrance that specify what kind of dish to bring. *Please sign up to bring a dish on as many Fridays as you can!*

St. Vincent de Paul “Brown Bag Collection”

Please continue to help our food bank here at Sacred Heart by taking a brown bag and filling it with non perishable foods. Every Friday the St. Henry-Sacred Heart St. Vincent de Paul Society has a food bank that is open to anyone living in the Fort Wayne area. Please bring the filled bag back by the 2nd Sunday of each month and it will be exchanged with another empty brown bag. This gives everyone an opportunity to help feed the poor in our city with this corporal work of mercy. Thanks in advance to all those who help keep the food bank in operation. Please note that though the food bank has moved to St. Henry’s for the convenience of the patrons, we nevertheless continue to assist it.

REGULATIONS FOR LENT

Lent begins on Ash Wednesday, Feb. 17. The following are the barest minimum obligations which must be observed by Catholics under pain of serious sin (if there is no serious excusing cause). Abstinence from meat is observed on Ash Wednesday, Good Friday, and all the Fridays of Lent by all Catholics 14 years of age and older. Fasting is observed on Ash Wednesday and Good Friday by all Catholics who are 18 years of age but not yet 59 years of age. Those bound by this rule may take only one full meatless meal. Two smaller meals, not equaling together a full meal, are permitted as necessary to maintain strength according to one’s needs, but eating solid foods between meals is not permitted. If there are any questions about when one would not be obliged to this observance, please ask the pastor. The older regulations are given at the end of this bulletin for those who wish to observe Lent in a more traditional manner.

STATIONS OF THE CROSS

There will be Stations of the Cross each Friday evening during Lent beginning at 6 PM, followed by Mass at 6:30 PM. Please join us for this special Lenten devotion. Normal First Friday devotions will be suspended during Lent.

MASS REQUESTS

If you desire a Mass to be celebrated for a particular intention, please place the offering along with the specific intention in writing in an envelope clearly marked **Mass Intention** and place it in the collection basket or hand it to the priest. For intentions for a specific individual, make sure to specify whether the person is living or deceased. Alternatively, you can approach the pastor or bring or mail the request to the church. We do not accept telephoned or emailed requests. Everything must be together at the time the request is made. Please note that Mass stipends are NOT tax-deductible according to IRS regulations.

OLDER LENTEN REGULATIONS FOR DEVOTIONAL PURPOSES (NO LONGER BINDING ON THE CONSCIENCES OF CATHOLICS)

Fasting was observed on all days of Lent, Sundays excepted. Contrary to what many believe and what many currently available “traditional” calendars claim, this even applied to major feast days (St. Joseph and the Annunciation), in order to preserve the integrity of the forty days of fast. Complete abstinence from meat was observed on Fridays and the Ember Days of Lent. Partial abstinence (meat allowed once) was observed on the remaining days. Although these regulations no longer bind, anyone able to do so is exhorted to follow the more strict, traditional fast and abstinence during the season of Lent. Although not as meritorious as when it was required by the Church, because now only the virtue of temperance, but not obedience, is being exercised, fasting is still a valuable means to bring the appetites under control and free the mind to contemplate higher things, as long as any temptation to pride is avoided, as the Pharisee who boasted about his observance of fasting.
