

DISPOSAL OF OLD PALMS

Every year prior to the commencement of Lent, last years palms from Palm Sunday are colleted and burned by the parish. These ashes are collected and then used for ash Wednesday. The palms symbolized the triumphal procession of Christ towards his crucifixion and our willingness to go with him. Throughout the year all deviations from following Christ are likewise bound to the palm, just as the Israelites held the palms and then to their shame fled in fear when the cross came into focus. For this reason the palms are also our symbol of repentance. A palm for recognition of the way of the cross, and burnt palms for the foundational sin of abandoning the way of the cross. Please place your palms from last year in the containers set aside in the church so we can fully participate in this symbolism from Palm Sunday and Ash Wednesday..

REGISTRATION DRIVE

If you derive benefit from the common good of Sacred Heart Parish and contribute to Sacred Heart—please register. Practically speaking, registration simply changes the virtue that the priest exercises when ministering to you. I have an obligation under justice to minister to those who are under my charge (registered). I use charity for all other Catholics who are under the charge of another. Just as priests have to be under somebody in authority, so do all Catholics. You should be registered somewhere—too belong somewhere. Where you are registered should be where you derive benefit from the common good of that church, and therefore contribute to that common good according to your abilities.

We have parishioners who have been registered for years who reside outside the diocese; Ohio, Michigan, Lafayette. I say this to alleviate any confusion for those who have refrained from registering because they don't "technically" reside within the territory of the diocese. You should be in our directory, you should be counted as souls under Sacred Heart's charge, you should be registered in my system.

+FRIDAYS OF LENT+:

We are offering a simple meatless supper on the Fridays of Lent (February 24, March 3, 10, 17, 24 and 31) following Stations of the Cross at 6:00 pm and Mass at 6:30 pm. The Church will provide drinks and some of the food but we need people to pitch in and sign up to bring DESIGNATED FOOD on the menu. There are detailed SIGN UP SHEETS for all six Fridays of Lent on a blue clipboard on the table by the west entrance that specify what kind of dish to bring. THIS IS NOT A REGULAR TYPE OF POTLUCK – NO DESSERTS AND ONLY BRING FOOD DESIGNATED ON THE SIGN UP SHEETS. Please sign up to bring a dish on as many Fridays as you can! REGULATIONS FOR LENT

Lent begins on Ash Wednesday, Feb. 26. The following are the barest minimum obligations which must be observed by Catholics under pain of serious sin (if there is no serious excusing cause). Abstinence from meat is observed on Ash Wednesday, Good Friday, and all the Fridays of Lent by all Catholics 14 years of age and older. Fasting is observed on Ash Wednesday and Good Friday by all Catholics who are 18 years of age but not yet 59 years of age. Those bound by this rule may take only one full meatless meal. Two smaller meals, not equaling together a full meal, are permitted as necessary to maintain strength according to one's needs, but eating solid foods between meals is not permitted. If there are any questions about when one would not be obliged to this observance, please ask the pastor. The older regulations are given at the end of this bulletin for those who wish to observe Lent in a more traditional manner.

OLDER LENTEN REGULATIONS FOR DEVOTIONAL PURPOSES (NO LONGER BINDING ON THE CONSCIENCES OF CATHOLICS)

Fasting was observed on all days of Lent, Sundays excepted. Contrary to what many believe and what many currently available "traditional" calendars claim, this even applied to major feast days (St. Joseph and the Annunciation), in order to preserve the integrity of the forty days of fast. Complete abstinence from meat was observed on Fridays and the Ember Days of Lent. Partial abstinence (meat allowed once) was observed on the remaining days. Although these regulations no longer bind, anyone able to do so is exhorted to follow the more strict, traditional fast and abstinence during the season of Lent. Although not as meritorious as when it was required by the Church, because now only the virtue of temperance, but not obedience, is being exercised, fasting is still a valuable means to bring the appetites under control and free the mind to contemplate higher things, as long as any temptation to pride is avoided, as in the case of the Pharisee who boasted about his observance of fasting.
